



















# PUBLIC HEALTH SYSTEM RECOVERY & RESILIENCE



The USAID Public Health System Recovery and Resilience Activity (PHS R&R), led by Pact, is a five-year activity that aims to strengthen the Government of Ukraine's (GOU) capacity to prevent, detect and respond to public health threats; sustain critical public health services during crisis; protect the health of all Ukrainians including vulnerable and marginalized population groups; and expand mental health support to war-affected populations. By applying a whole systems approach to assist the GOU to improve core national and regional public health capacities to address health challenges during wartime and the post-war future, PHS R&R contributes to USAID's efforts in supporting Ukraine to achieve long-term national health security and stability.

#### **KEY OBJECTIVES AND ACTIVITIES:**



#### Objective 1. Prevent, detect and respond to public health threats

- ▶ Targeted support to the regional Centers for Disease Control and Prevention (rCDCPs) to strengthen their preparedness and response to new waves of COVID-19 in the context of war and health system overload
- ▶ Implementing measures to improve public health resilience in terms of readiness, response, and recovery
- ▶ Improving the system of data collection and use for decision-making
- ▶ Increasing COVID-19 vaccination coverage
- ▶ Improving risk communications capacity
- ▶ Promoting the continuity of essential medical services at the primary healthcare level



# Objective 2. Sustain critical public health services during crisis

- ▶ Strengthening the capacity of the rCDCPs to effectively operate and implement the 10 essential public health functions
- ▶ Strengthening the capacity of the public health system in two priority areas under the Global Health Security
  - » readiness to prevent, detect, respond and effectively recover from emergencies;
- strengthening risk communications
- ▶ Increasing routine immunization coverage
- Improving the detection of morbidity at the primary level

# Objective 3. Strengthen community resilience against potential public health risks

- Raising awareness and involvement of territorial communities in addressing public health issues
- Developing coordination and communication mechanisms with other partners
- ▶ Implementing community-based services, including communications to increase vaccination rates, preparedness for and response to emergencies, identification of vulnerable populations and at-risk groups, hpromotion of timely care-seeking behaviors, reduction of barriers for accessing health services, and stigmatization reduction for mental health.



#### Objective 4. Expand access to mental health services

- ▶ Capacity building for mental health and psychosocial support (MHPSS) programs at the national level Implementahhsolutions using digital tools and platforms
- Expanding the training of mental health professionals and non-professionals for increased access to MHPSS services
- Co-creation and piloting of tailored stepped-care models of community-based MHPSS services
- > Strengthening regional-level capacity, coordination, and integration of mental health in public health
- ▶ Expanding access to community-based mental health services using evidence-based MHPSS models
